Applicants must be a citizen of the United States of America, eligible for a Hunting and Fishing License and of suitable character and interest of the Earlton Fish and Game Club.

Applicants will need 2 club members to sponsor membership and sign application prior to submitting.

Members are responsible for 5 service hours per year in lieu of \$50 assessment plus dues. It is expected that members will participate and attend fundraising events.

Application Fees: Initiation Fee \$40.00 plus Annual Dues \$100.00 prorated quarterly received by the month of application.

- Jan/Feb/Mar \$100 Dues + \$40 Initiation Fee (Total \$140)
- Jul/Aug/Sep \$50 Dues + \$40 Initiation Fee (Total \$90)
- Apr/May/Jun \$75 Dues + \$40 Initiation Fee (Total \$115)
- Oct/Nov/Dec \$25 Dues + \$40 Initiation Fee (Total \$65)

If the applicant is applying with their spouse, only one Initiation Fee will be collected for both applicants. If the applicant's spouse is already a member, then the Initiation Fee will be waived for the new applicant

The application is to be presented to the membership by the sponsor(s). The sponsors will speak on the applicant's behalf. The Applicant needs to attend one meeting with at least one of the sponsors to address the membership prior to being voted in. Voting generally takes place at the meeting after the applicant attends and addresses membership. Attendance is not required to be voted in.

New Members will get oriented to the Bylaws, Operating Procedures and club property and rules before using facilities. Paid memberships expire Dec 31st each year and need to be renewed for the following year
